Dear Secretary Bradshaw,

We, the undersigned industrial hygienists, safety engineers, seniors and managers of the Division of Occupational Safety and Health, are writing to express our deep concern about the pending continuation of corrosive inequalities in Cal/OSHA's pay scales, and to urge your immediate intervention as a Cabinet officer of the Schwarzenegger Administration to achieve pay parity in the current Unit #10 contract negotiations.

The latest, "final" proposal by the State to industrial hygienists represented by CAPS – California Association of Professional Scientists would close the current 14.6% to 22.5% gap in pay between Cal/OSHA safety engineers and industrial hygienists to a 6.8% to 7.6% difference for only the six months between January and July 2007. In July 2007, the industrial hygienists' pay lag would grow again to over 15% with the raises included in the existing contract for bargaining unit #9 (Cal/OSHA safety engineers).

As documented by the State DPA (see attachments), Cal/OSHA industrial hygienists are more than 20% behind hygienists working for other public sector agencies such as cities, counties, and the UC system. But there is also the 20%-plus gap between the pay of Cal/OSHA's safety engineers and industrial hygienists.

This pay inequality is very corrosive to the internal functioning of the agency and has led to widespread transfers from the industrial hygiene to safety engineer classifications. The pay inequality sets up a two-tier system of Cal/OSHA inspectors, with one class (IHs) as abandoned second-class citizens within the Division. Moreover, this pay inequality makes it virtually impossible to fill current and future IH position vacancies in the Division.

If pay parity is not achieved between safety engineer and industrial hygiene inspectors, the Agency can only expect a growing wave of "out of class" pay grievances as IHs are doing much the same inspections as safety engineers in our joint efforts to protect workers' safety and health in California. Cal/OSHA cannot function with two unequal classes of employees.

We write – members of both bargaining units #9 and #10 in compliance, consultation and headquarters – to urge you in the strongest possible terms to establish pay parity between the Division's safety engineers and industrial hygienists. The current negotiations with CAPS provide the opportunity to achieve this goal.

In **July 2007**, the Safety Engineers in Bargaining Unit #9 will receive another raise (not matched by the contract for industrial hygienists) of between 7.4% and 12.4%, depending on classification and seniority. The pay differential between safety engineers and industrial hygienists will again grow to be in the range of 15-20%.
